Cost for shipment of the fabric should be annotated as well on the attached form. Fabric is to be purchased by the vendor awarded the contract.

Vendors must propose pricing for all items, offers on less than all items being solicited will not be considered.

The refinishing and reupholster work is to be accomplished prior to September 25, 2017.

#### PART 1 GENERAL

#### 1.01 RELATED DOCUMENTS

A. Drawings and general provisions of the Contract apply to this section.

## 1.02 DESCRIPTION OF WORK

- B. Customer's own material (COM) for fabrics have been selected for items noted here-in.
- C. Several wood furniture items have been identified for either a complete refinish/restain or

#### 1.03 REUPHOLSTERY AND REFINISHING REQUIREMENTS

- A. All work will be performed on site and in place within facility. Contractor will supply/provide all materials and equipment required to perform services and will be responsible for maintaining a clean worksite at all times.
- B. Contractor will provide a full schedule and process steps to perform services on site.
- C. Contractor will report and evaluate any items that do meet scope of work requirements prior to commencement of work on that item.
- D. Contractor will be responsible for all labor and materials required for the reupholstery and wood refinishing of identified items.
- E. Contractor is responsible for the calculation of all required yardage for each item scheduled for reupholstery from the provided scheduled fabrics.
- F. All fabrics will be precision cut. Stitching and seams will match existing pieces unless otherwise noted.
- G. All identified furniture for refinishing/staining will use aniline dyes to to recreate original factory color or scheduled new stain color.
- H. All scheduled furniture to be stained or for touch-up shall be thoroughly cleaned with waterborne cleaning solvents to remove dirt, oxidation, and foreign materials from surfaces to be refinished.sanded to create a smooth uniform surface.

- All furniture shall be sanded so as to create a smooth surface. All cirgarette burns, deep gouges and scratches shall be repaired.
- J. All scheduled furniture to be stained or for touch-up shall be toned using specially prepared Contractor's pigmented waterborne lacquers.
- K. density, water and stain resistant, waterborne lacquer. Laquer designed to penetrate and adhere to to previously applied color

#### 1.04 QUALITY ASSURANCE

A. Prior to commencement of work, contractor to provide samples of specified materials and stain matches for owner sign-off.

#### 1.05 COORDINATION

- A. Product descriptions, images and location drawings with key codes for reupholstery and wood refinish are included in the package.
