U.S. Court of Appeals for the Sixth Circuit List of Permissible Filings Under ECF

To file a document in ECF you can type a key word in the "Type of Document" box that best describes what is being filed. For example, if you type "brief" the list below will filter to entries with the word "brief" as part of the document type. You can then scroll through the list to find the desired entry. You can also add an additional key word, for example, "sealed brief" would further narrow the list to filter entries to only those containing the words "sealed brief". Another way to filter the entries is to select a Category from the "Category" column. For example, selecting the "Case Opening Forms" category will filter the list to entries in that category.

For entries that require a relief be requested, the screen functions the same way as the "Type of Document" screen described above. The "Relief" and "Relief Category" columns are used to filter the exhaustive list of potential reliefs. Repeat the search and select to include multiple reliefs.

The rest of this document will be a list of the available entries grouped by the category/categories to which they belong.
