- Give the form a name that you will recognize; during the docketing event, you will be prompted to upload the form to the ECF filing system.

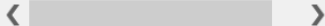

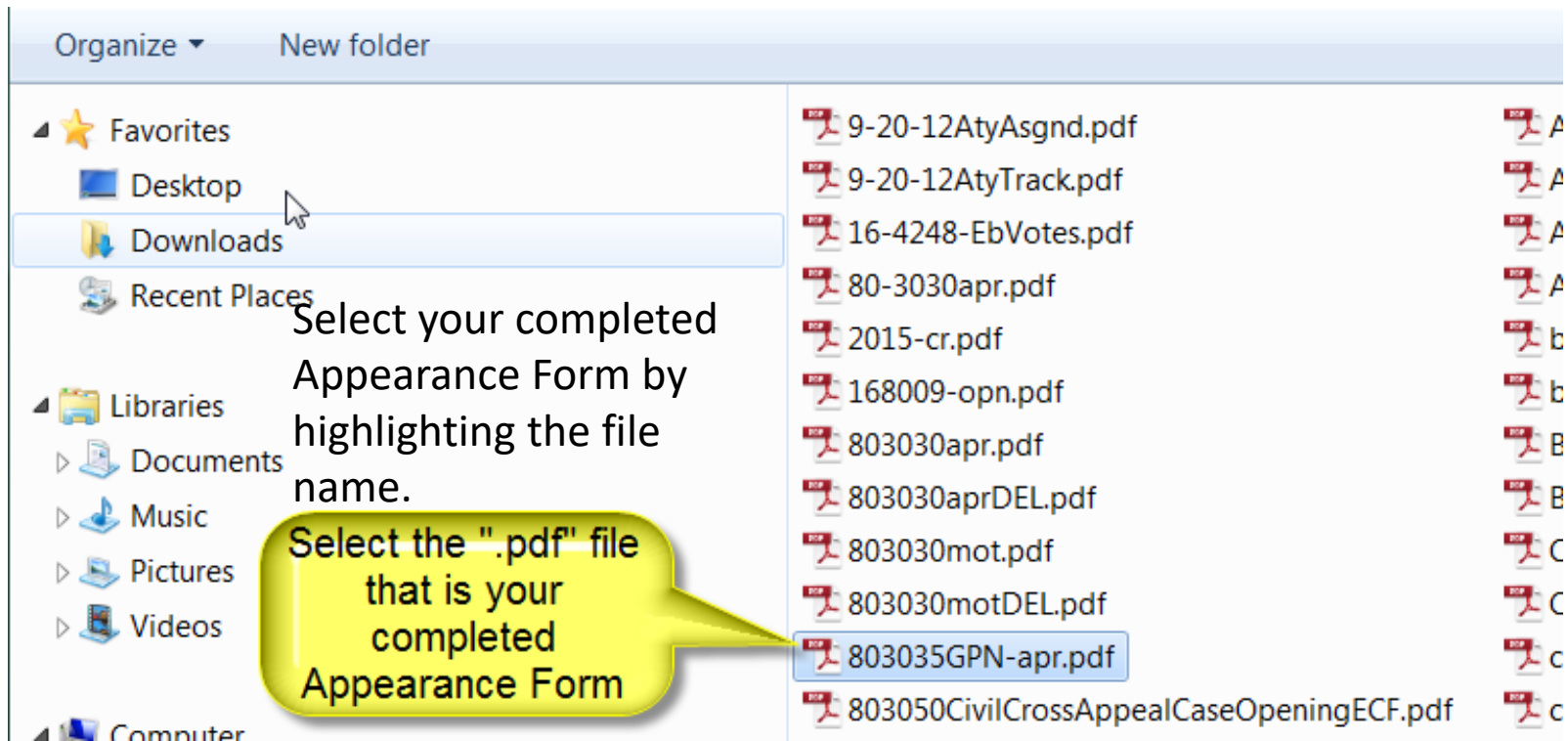

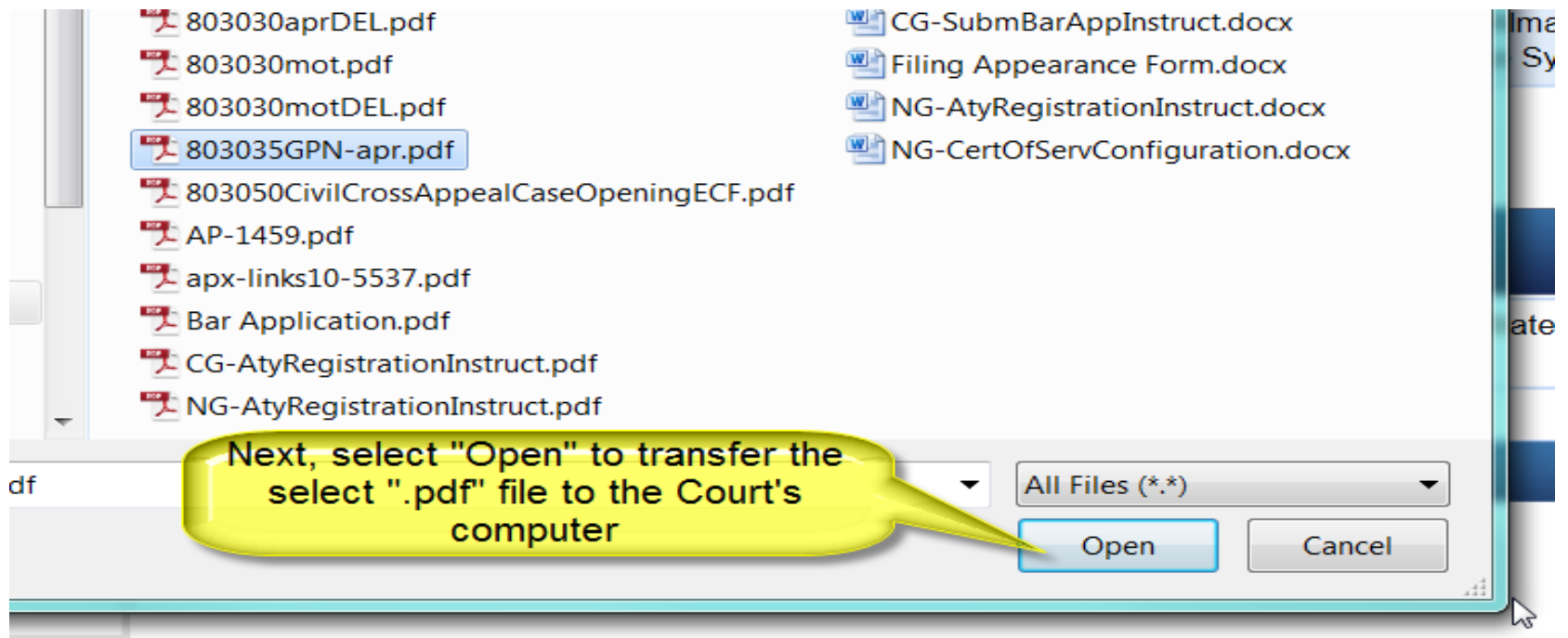
