Instructions for Paying a Filing Fee for a Docketed Case

1. Turn off pop-up blockers in your browser.
2. Log in to NextGen CM/ECF.
3. Select Filing.
4. Enter the Case Number.
5. Type “fee” in the “Type of Document” field, the list below will filter.
6. Select “pay BAP appeal to 6th Circuit fee”, “pay original proceeding fee”, or “pay petition for review filing fee”, as appropriate.
