**STATE OF MISSISSIPPI'S UNOPPOSED MOTION FOR A TWO-WEEK
EXTENSION TO FILE PROPOSED FINDINGS OF FACT AND
CONCLUSIONS OF LAW AND POST-TRIAL BRIEF**

Plaintiff moves the Special Master for a second short extension of the post-hearing submission deadline, from September 5, 2019 to September 19, 2019. In support of this motion, Plaintiff states this short request is made due to scheduling conflicts arising from an antitrust, class action trial proceeding in the Southern District of Illinois that includes both Neal & Harwell and Barrett Law Group.
