The instructions below include changes uploaded to this website on November 15, 2024. The instructions are current through January 1, 2024. A brief summary of the changes can be viewed here: Updates.

Updates

The Committee added one new instruction:

Inst. 1.07B Credibility of Witnesses – Law Enforcement Officer This new instruction provides more detailed guidance on how to evaluate the testimony of law enforcement officers.

The Committee updated the text and commentaries of existing instructions:

Inst. 1.02 Jurors' Duties

In paragraph (4), the word "impartially" was added, and new paragraph (5) provides detail on the kinds of stereotypes that jurors should be careful to avoid.

Paragraph (2)(E) on the definition of "during and in relation to" was revised based on Dubin v. United States, 143 S. Ct. 1557 (2023).
